The Secretariat would like to inform you that the European Commission is organizing a conference <u>entitled "*local agriculture and short food supply chains - preparing for CAP 2020*" taking place <u>on Friday 20 April 2012</u>: you will find attached the provisional program of the conference.</u>

This event, which is a joint initiative of the European Commissioners Dacian CIOLOS and John DALLI, aims at discussing "ways" to mobilise and value the economic and environmental potential of local agriculture and short food supply chains. - The remaining seats should be allocated to members of the Working Party on "Assurance Quality in Agriculture" as well other experts emerging from relevant Working Parties interested in these issues.

Please note that **only one seat per organisation** will be allocated and that **priority will be given to national experts**: only in case we cannot fulfill the quota fixed by the European Commission, the remaining seats could be allocated to Brussels based representatives.
